

Good Evening, Everyone,

I hope this message finds you well as we enter the month of October! Please find below updates and reminders for the school community.

COVID Positives October 1, 2021

Today we are reporting three COVID positive cases. Two are at SWIS and one is at AHS. Close contacts have been notified.

As noted below, we are close to beginning our “Symptomatic Testing” and “Test and Stay” options for asymptomatic close contacts. If you have yet to opt into this program more information is below. Unfortunately, assurances made by the state regarding personnel to staff this program has not materialized. As a result, we have secured our own personnel to operate this program. There is a period of training that needs to be completed and we are hopeful we will have this program going very soon.

Continuation of Masking in the APS

As referred to in the Commissioner’s most recent memorandum to all school districts in the Commonwealth, the masking order in all schools has been extended through at least November 1, 2021. As we approach November, we will continue to keep you apprised of the direction received from the state.

Reminder Regarding Masks

Related to the previous paragraph, please be reminded students are responsible for supplying their own masks. Schools have extras for students and visitors who forget them, but we appreciate your help providing a mask for your child.

Substitute Nurses

The Auburn Public Schools is looking for substitute School Nurses. If you are a Registered Nurse or know someone who is and are interesting in working in our school buildings, please contact either Leah Gauthier, Lead Nurse, at lgauthier@auburn.k12.ma.us or Beth Chamberland, Assistant Superintendent, at echamberland@auburn.k12.ma.us. Substitute RNs receive a daily rate of \$ 150 and you get to work with our amazing students and staff.

Substitute Teachers and Support Staff

The Auburn Public Schools is looking for substitute teachers and support staff. If interested, please come to 5 West Street to complete an employment application. Applications are reviewed and training is provided to qualified candidates. Applicants should have an Associate or Bachelor's degree. You are able to select the days you work to make it convenient for your schedule. You can also select the school or schools

you would prefer to support. Substitutes for teachers are paid \$80-\$85 per day based on certification, Instructional Assistants are paid \$ 12/hour, ABA substitutes are paid \$ 12.30/hour and retired teachers who retain their certification are paid \$ 90 per day.

COVID Testing

Due to a shortage of personnel available at the state level, we have elected to secure our own personnel to work with the testing company to begin this program. More information will be forthcoming. We are moving as fast as we can. However, if you have not consented to this program, the information is below. Thank You!

Please see the information below, shared in an earlier email regarding the COVID Testing Program that is coming soon to the Auburn Public Schools. If you are interested in having your child participate, please follow the link to complete the consent form.

Symptomatic Testing

Under this program, we will be able to test staff, and students (with the consent of a parent or guardian) who may become symptomatic in school. Staff, and students with very mild symptoms and a negative COVID test, may be allowed to stay in school.

Test and Stay

In addition, staff, and students who may be deemed “close contacts” to a COVID positive person in school, can opt to be tested daily in school for at least five days. If the test is negative and there are no symptoms present, staff, and students will be allowed to stay in school.

Details

The testing that is being offered will not allow us to test students or staff who become symptomatic outside of school or become a close contact to someone who is COVID positive in a setting other than school. Please do not send your child to school if he or she is not feeling well.

Parent/Guardian Consent

In order to implement these programs, we must receive consent from parents or guardians in order for any child to be tested. If you would like your child to participate in the testing and monitoring that these programs will provide, please follow this [link to the consent form](#) and complete the form for your child(ren). If you do not complete the consent form or deny consent through the form, we will not include your child in any of the testing that will be offered.

If you provide consent, please note that you will be providing consent for Symptomatic Testing, Test and Stay and Routine COVID Safety Checks (formerly named Pooled Testing). However, at this time, the Auburn Public Schools has only opted to offer the Symptomatic and Test and Stay options.

If you are registering your child(ren), please select 'sign consent for a minor' and enter the requested information. If you have more than one child, please complete a form for each child.

Once into the consent portal, you have the option to select languages other than English for the translation of the consent form.

Please complete the consent form as soon as possible so that we can offer a robust response to students.
