SUPERINTENDENT'S REPORT:

Spotlight on Students:

Dr. Chamberland introduced Swanson Road Intermediate School Principal Susan Lopez. Mrs. Lopez introduced Jessica Burbank, 4th grade teacher and the following fourth grade students:

UNFINISHED BUSINESS:

School Choice Enrollment for 2023-2024

Dr. Chamberland: There has been a review of the expected enrollment in grades 6-12 for the 2023-2024 school year. I have shared the numbers with you in your packet. We have 13 school choice students who will graduate in June, and a small class of students entering grade 6. The recommendation before you for the number of additional students to be accepted into the Auburn Public Schools via our School Choice option in grades 6-12 is 15 for the middle

school and 15 for the high school with a total of 30 new school choice students. We are specifically looking to add in the 6th, 9th and 10th grades, as well as any siblings of current school choice students in other grades. This will result in the total number of school choice students at 92 accepted students, for the 2023-2024 school year. I have spoken with Ed Kazanovicz regarding the 2 incoming housing developments. One seems to have stalled. Perry Place looks to proceed, but is a year or two out. It should not impact our enrollment at this time, and we can revisit our numbers next year.

Brooke Wrenn: The numbers make sense..

NEW BUSINESS:

Site Manager Stipend

Dr. Chamberland: Building usage, primarily at Auburn High School and Auburn Middle School is seeing a significant rise. COVID 19 had a negative impact on the number of site managers available to us. The recommendation before you is to increase the site manager stipend from \$15/hour to \$20/hour to allow us to better supervise and monitor groups in our buildings.

TEACHING AND LEARNING REPORT:

Alan Keller: Greg Walton and I have been working together throughout the year enhancing the skills and knowledge of our staff in behavior management and de-escalation. One of the ways we are doing this is by increasing the number of certified Crisis Prevention Institute (CPI) trainers from one to three. This offers us increased flexibility in delivering formal training to staff members whose positions require certification in verbal and physical intervention techniques. In addition, our trainers have presented to the faculty at each school offering foundational knowledge in escalation and tools, the goal of which is to equip all educators with strategies that they can apply regularly to support all students.

Dr. Chamberland shared a story regarding a strategy that was shared at a training that she found interesting and helpful.
